## Public Comments: N/A

Commissioners reviewed the proposed County Surplus Property Form.

Motion by Olson to approve the County Surplus Property Form, seconded by Keiser. Ayes: Unanimous

Olson stated he had received a call from (Unknown) Vrbas about interest in the County Road Worker position, but has not received an application from him.

Pam Reichert discussed 5 year hazard mitigation plan. Stated it is required to receive homeland security grants. Dundy County usually splits the cost with Chase and Perkins Counties. Discussed meeting with Jim Burgeson in which Communication Center renovation was discussed. Reichert stated she would like to discuss a situation she was unhappy with in which she recalled speaking with the Perkins County Sheriff at a meeting in which that individual relayed that Sheriff Smith had referenced the Communication Center renovation being for the purpose of building a new kitchen.

Miles Preston requested a written payroll policy be presented to the Clerk's office for Sheriff's Office employees. Sheriff Smith stated that he was working with a person named Linda from Nirma to develop a written payroll policy.

Sheriff Smith and Chief Deputy Ryan King discussed Sheriff's Office vehicles, and stated they were on the waiting list for a Dodge Durango for law enforcement vehicles. Cost would be approximately \$32,000.00 for a fully equipped vehicle. Also discussed purchasing a sheriff vehicle from Hays County in the ballpark of \$30,000-35,000.00. Commissioners said to move ahead with the Hays County vehicle purchase once a price is in writing, and to remain on the list for the other vehicle, but keep an eye out for a pickup.

Vince Turpin discussed EMS ride-alongs for a 16 year-old student. Commissioners attempted to reach Bryon Barnett with NIRMA to discuss work-comp and discuss any liability concerns. Turpin stated that the new cot for the ambulance was received, and that the state grant reimbursing a large portion of the cost should be coming in soon. Turpin stated that they still need to find a certified installer for the cot, and that he believes the closest is in Denver, but he's had trouble hearing back from them. Also stated that the new ambulance is in progress, and when it's delivered the old ambulance will need to be moved to surplus and sold. Discussed adding drivers for long hauls: Drivers are required to by 18 or older, posses a driver's license, and pass the Emergency Vehicle Operations Course. Asked if the board would prefer the drivers to be First Responder certified, but added that it's difficult to find First Responder classes locally. Turpin stated he would like the drivers to be CPR certified at minimum. Turpin is a certified CPR instructor, and Tony Ham is a certified EVOC instructor.

Olson called Pinnacle Bank about the county credit card progress. Mary Deyle stated that her understanding was the credit card application process was put on hold.

Kris Mathews delivered the Dundy County Hospital report. Stated seeing the budget hearing recording and wanted to address public questions. Mathews stated that the public had questions about how profitable the hospital. Mathews stated the hospital is not profitable, and presented financials from the past 5 years. Mathews explained that the hospital was only profitable during the Covid pandemic due to government funding. Mathews also addressed the hospital EMR system crossover difficulties, and that that process was improving. Stated that Medicare patient care will never be profitable, and that 60% of the DCH patient base is Medicare. Stated that taxpayer dollars were approached as a means to get the hospital back into the black, and/or be used for capital. Mathews discussed a daycare solution for the Hospital. Stated that if the daycare was provided for only hospital employee daycare, its costs would be reimbursable, but that he would prefer a community solution rather than a centralized hospital solution. Mathews said that on the other hand, the hospital could provide meals to a community daycare, and those would be reimbursable, but DCH would not be able to be associated with it. Mathews asked the board if they would be willing to create a community daycare and appoint a department head. The board stated they would consider the proposal.

With no further business, Chairman Olson adjourned the meeting at 10:01 A.M. The next regular meeting of the Dundy County Commissioners will be held on November 6th, 2023 at 8:30 A.M.
