Dundy County Hospital, Dundy County Stratton Schools, and the City of Benkelman have already committed support to a plan to provide daycare within the community.

Board discussed a proposed emergency Road south of the railroad tracks in Benkelman. The emergency road would travel across Frenchman Valley Coop, Todd Burrell, and the City of Benkelman's properties. County Attorney's office will be working with involved parties to organize an easement agreement for emergency access only.

Discussed guard rail cost for a section of the Max-Wauneta Rd. Will take expenditure from the Highway Buyback Fund when due.

Amy Frederick discussed Dundy County's support for the Food Pantry. Also addressed potential improvements to the back portion of the Food Pantry.

Tish Burrell submitted Tax List Correction No. 791. Also discussed Bryan Hill Appraisal Firm being contracted to complete property valuations for Dundy County.

Motion by Keiser to approve Tax List Correction No. 791 for Property ID 290005507 – RE, Seconded by Richard.

County Attorney Arlan Wine delivered the County Attorney's report, discussed the County Personnel Handbook. Corrected a statement made by County Clerk Miles Preston, in which Preston stated that he believed there was a requirement for a Sheriff to live within their county within one year of taking office in that county. Statutorily there is not a one-year grace period, the Sheriff shall live in the County of which they hold office.

Interim Sheriff Ryan King delivered the County Sheriff's Report. Discussed a bid to paint the jail.

Commissioner Aaron Keiser discussed NACO Conference points of interest. Discussed proposed Consumption Tax initiative.

City Superintendent Tim Smith discussed the bulldozer being used at the city dump site. The city of Benkelman and Dundy County agreed to cost share a replacement for the equipment, in the price range of \sim \$60,000.00.

Chairman Olson recessed the meeting at 11:09 A.M., will reconvene at 1:15 P.M.
